Lalor North Primary School is looking forward to another great year of teaching and learning in the Greek Bilingual Program and would like to advise you of Lalor North Primary School's voluntary financial contributions for 2026.

Schools provide students with free instruction to fulfil the standard curriculum requirements, and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing support of our families ensures that our school can offer the best possible education and support for our students. We want to thank you for all your support, whether that is through fundraising or volunteering your time. This has made a huge difference to our school and the programs we can offer.

Your ongoing financial contributions are crucial to ensuring our students have access to the best, up to date resources, facilities and opportunities they deserve. Without this financial support, many resources that improve our children's education would not be possible.

School Council completes an annual review of the Parent Payment Policy and Parent Payment charges every year. The contributions from families have made a significant impact, enabling us to offer special curriculum opportunities that would not have been possible otherwise.

In 2026, family contributions will support us to provide both the quality and visibility of the Greek Bilingual Program. Specifically, contributions will go towards:

#### **Structure & Organisation**

- Expanding to a four-grade model and supporting a balanced structure to ensure more personalised learning.
- Increasing in-class support, to allow more targeted assistance for students at different stages of learning.
- Providing the crossover day for both language teachers of Greek and English to work on the same day to support a smooth handover for students.
- Support for increasing our furniture and equipment.

#### **Resource Development**

- Catering for our growing enrolment and the additional resources required to teach with proficiency.
- Purchasing and developing quality Greek language resources, including books, bilingual texts, and literacy resources in both Greek and English.
- Purchasing and developing quality Greek and English phonics resources to strengthen early reading and writing skills.
- Enrichment of literacy and numeracy programs taught through Greek, strengthening bilingual proficiency.
- Extension programs for high ability students and support programs for students that require additional support.
- Developing improved home learning resources, as requested by families.

# **Greek Bilingual Promotion**



- Promoting our unique bilingual program within the wider community with new promotional materials.
- Supporting the Greek Storytime initiative at our school for Greek language development from an early age.
- Purchasing Greek merchandise, props, flags and cultural resources to enrich celebrations and cultural events, as part of the teaching and learning of culture.
- Celebrating Greek culture and heritage through special events and performances that connect students with language, heritage, and pride, such as Easter traditions, Flag Festival, Ohi Day and Independence Day.

#### **Digital Technologies**

- Providing students with high-quality, up-to-date laptops, including regular updates, repairs, and ongoing maintenance
- Purchasing STEAM resources, such as robotics, coding equipment, and digital tools for the 21<sup>st</sup> Century learner.
- Expanding access to online learning platforms for both English and Greek to support teaching and learning.

#### Wellbeing

- Providing greater access to wellbeing resources for students in classrooms.
- Strengthening the wellbeing team to include mental health support staff and the opportunity to employ a psychologist.
- Supporting student leadership programs that develop student voice and agency.
- Purchasing a variety of resources and developing social skills programs to support health and physical activity initiatives.

We encourage payments to be made by Friday 12th December 2025.

Finally, we would like to also add that we are proud of the broad range of programs and opportunities available at Lalor North Primary School. These would not be possible without the generosity of our families. Please be assured that voluntary contributions are kept to a minimum to remain affordable for all parents.

# FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access
  to all items, activities and services that are used by the school to fulfil the
  requirements of the Curriculum. This includes the Victorian Curriculum F-10, the
  Victorian Certificate of Education (VCE) including the VCE Vocational Major and the
  Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.

# PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:



#### Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

# Other Contributions

Voluntary financial contributions for noncurriculum items and activities that relate to the school's functions and objectives.

# Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

 Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



# FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot
  pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



# SCHOOL PROCESSES

 Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
